



## 2016 Membership Drive & Contest



Our 2016 annual membership drive and fundraiser gets underway the first quarter of 2016. In the previous year,

approximately 70 Cougar Gulch households participated by paying membership dues of \$25 per family. With over 300 homes in the area, we encourage all members to spread the word about Hall events, membership benefits and rental opportunities. This year our goal is to increase our membership to at least 100 families.

Your membership dues and contributions pay for the Hall's necessary expenses including electricity, propane, building insurance and taxes. Funds also support our Hilander 4H club and provides supplies for rentals and community events and pays for minor

improvements to the Hall. Your contributions are TAX DEDUCTIBLE. This yearly membership drive is vitally important to help maintain the Hall as a strong community connection for all families of the Gulch and offers wholesome, fun events throughout the year.

Again this year, we will hold our "early-bird" contest. All families paying their 2016 membership dues between <u>January 1 and March 31</u> will be in the drawing to win a \$50 VISA card. The winner will be selected at our regular April board meeting.

Remember, all contributions to the Sam Rodius Memorial Park Association (SRMPA)

## **Community Hall Capital Improvement Project for 2016**



It started with a leak. A small roof leak in December, 2014. The leak was discovered in the storage area. In 2015, the board hired a contractor to provide an estimate to fix the leak and paint the exterior of the Hall. This started our journey of discovery.

In the summer of 2015, the contractor informed the board that the current exterior condition of the Hall was in such dire condition that cleaning and preparing it for new paint was not feasible. The roof leak was repaired in the final months of 2015 and the board then began investigating options to preserve and save the Hall's exterior. A resident volunteered her time and

met with a builder at the Hall. The discovery was that the foundation is sound and solid but the Hall needs to have insulation blown in to the existing structure and then be resided. Estimates for this work—supplies and labor—come in at approximately \$30,000.

This is undeniably a daunting task being faced by our board and we certainly cannot undertake this effort alone. We will need lots of community support. Our current financial report for December puts our operating finances at approximately \$3,000. This is money from donations, rental fees and membership dues. We use this money to operate the Hall on a monthly basis. The board approved a \$300 transfer of funds to our Savings Account and that will become the basis for our capital improvement fund for insulating and siding the Hall in the future.

The board brainstormed some opportunities to raise money for this effort at our last meeting. Look for these and other fundraiser ideas that you can participate in the future. They including the following:

- Ask the community to donate—consider asking for a 1-time, \$100 tax deductible gift from all residents.
- Hold an auction of donated items from residents.
- Hold a music/social event and charge admission.
- Increase rental rate to \$200 for non-members and organized social groups.
- Publicize and promote the Hall to increase our Hall rentals.
- Sell community "discount cards" to residents and others in the community.
- Ask for volunteers from the community with skills to blow in insulation and attach siding when appropriate funds are available. Fully half of the cost of insulating and siding the Hall is for labor. Everything we can save on this front will help reduce our overall costs.
- Consider updating one side of the Hall per year as building funds are available.
- Investigate and apply for appropriate grants to augment the fund.

We would love to hear your ideas on how we can raise money to save and preserve our Hall. Please send your suggestions to <u>julielinez1951@gmail.com</u>. All suggestions will then be presented to the board. Consider getting involved and helping to manage a fundraising event. All volunteers are welcome.

The board has approved all monies to support this project will come from fundraisers and donations (other than membership dues) and go directly into the savings account earmarked for this capital improvement effort. Look for additional information on this long-term project in the near future.

## **Community Hall For Rent**



The Cougar Gulch Community Hall, located at 8088 W. Meadowbrook Loop, can be rented by any local neighbor or resident of the Gulch. The Hall is also available to social and organized groups or companies. The Hall boasts a stocked kitchen with a propane wall heater, a large entertainment room with a stage, tables and chairs for approximately 80—100 guests, and a wood burning fireplace. The kitchen is moderately stocked with refrigerator, stove, microwave and utensils, bowls and cooking equipment including coffee and coffee pots.

Paper products (plates, cups, napkins, paper towels, toilet paper) and cutlery are provided as well as firewood to heat the Hall in the colder months. Consider having your next event at the

Hall. It's a great spot for family reunions, weddings, private functions, garage sales parties, plays and concerts! There is parking on site with an overflow parking lot immediately above the Hall for larger functions.

Please contact Julie Schmidt at 425-319-0915 to reserve your rental date. Paid family members can rent the hall for their personal use with a paid membership for \$75 per day. Companies and organizations can rent the Hall for \$200 per day. All renters will be provided a rental agreement to fill out prior to renting and a renter checklist for ensuring the Hall is clean at the end of each event. These documents will be provided at the time a rental date is secured.

Please note: The board does not have the means to plow the property in the event of snow.

### **Worley Highway District Notes**



Thanks to all who assisted in clearing roads of fallen trees following the windstorm of November 17<sup>th</sup>. Road district crews cleared 80 trees from roads, but I know there were more trees down than that. Many residents took the initiative to clear at least a travel way. Your help is much appreciated. Thank you!

Before the ground became too wet, we replaced several culverts and we did some brush clearing to improve sight distance. Delineators were installed along some roadways where

experience has indicated drivers have difficulty seeing the road in a snowstorm. The crew also prepared their respective snow removal equipment in anticipation of winter. As conditions permitted, gravel was spread and grading done on gravel roads. Rains and relatively warm temperatures breed potholes but freezing temperatures put a stop to that. As much as I enjoy mild weather, colder is better in these conditions.

Four crewmen began an education program that will lead them to being designated as "Road Scholars". Idaho's T2 Center does the training on our behalf. The knowledge they gain will help them do a better job of maintaining your roads.


## **Woodpecker Woes**
